FROM THE VICE PRESIDENT

What a great way to start off their 500th year! As I write, several members of the Association's Scientific Committee have just returned from Scotland where The Royal College of Surgeons of Edinburgh were in impressive form. James Garden and his team put on a hugely enjoyable, informative and well run Quincentenary Scientific Congress – one that is going to be difficult indeed to match next May. Fellows from across the globe; reflections on an awesome record of innovation over the centuries; international speakers; innovative sessions and excellent contributors - it was great stuff. And all those kilts, bagpipes and dancing, to boot!

Last year's ASGBI Meeting under Bob Lane's Presidency was, I also have to point out, an absolute cracker. Matching these extravaganzas will be a bit of a challenge, but match them we will and we intend to plagiarise like mad! Paul Redmond has finished his term as Chairman of the Scientific Committee, handing over the baton to Rowan Parks, and I would like to record our appreciation of Paul's achievements in modernising, overseeing and producing one of the largest surgical meetings in Europe, annually, for many years and to wish Rowan good luck in this important job. Well done, indeed, Paul and thanks on behalf of us all.

Our aim from the start of planning the 2006 Meeting has been to support the Edinburgh College 500th Anniversary and happily our meeting, coinciding as it does with the end of the year-long celebrations, will be held in the heart of Edinburgh at the excellent EICC.

So what do we have on offer? We have chosen for the theme of this meeting '*The Compleat Surgeon*'. The title has a certain ring about it, but there is a serious point as the underlying aim of the Meeting will be to provide some counterbalance to the increasing professional isolation that has crept in on the back of super specialisation. One of the defining characteristics of medics – and surgeons in particular – seems to be a large measure of curiosity. I believe that satisfying this stops us all from getting bored. As an aside, can I share with you that every so often our firm sneaks off to visit a local factory or business. From slip gauges (reference gauges for machine-tool setting) through pleasure boats (Marine Projects) to pasties (Ginsters), I do not think that we have visited a single manufacturer that has not taught us something that we as a local surgical service can apply. (Off to visit a paper manufacturer in the autumn – well, isn't there enough of the stuff around, these days?) In surgery it is impressive, is it not, how often one picks up little practical nuggets from other people's practice? So, with this in mind, we are going to take note of feed-back and experiment a little with the format of the Meeting.

On **Tuesday 2nd May 2006** we are going to expand the number of short courses that the Association started some years ago and which are proving very popular. We have taken a hard look at topics that we guess will be of interest – from Critical Care through to managing digital videos - and the committee will make final decisions on the basis of expressions of interest, so please do not delay in booking when the registration documents arrive. **Wednesday 3rd May** will comprise a heady mixture of scientific papers, quality lectures, the Association's AGM and a 'Hot Topic' section that worked so well last year. Most specialty societies hold two meetings annually and in view of the increasing difficulty we are all experiencing in taking time out, combining 'common trunk' CPD and a specialty meeting in this way may prove a good way of using this limited resource.

We will increase the content of 'pure' CPD in the form of the popular update lectures from the specialties and some non-surgical disciplines. These sessions will include experts from the UK and abroad. The whole of **Thursday 4th May** will be devoted to this, and there will be no competing parallel sessions on that day. One area that we were already planning to address and to which, in the light of recent tragic events, we will clearly have to pay even more attention, is the matter of major disasters and bomb blast injuries. I suspect that we will feature this in more than one part of the meeting.

Specialty needs will not be neglected, however, and the specialty societies will be conducting their own high-quality symposia in parallel on **Friday 5th May**. We are sure that these will be 'not-to-be-missed' sessions that will include national and international keynote speakers and the usual excellent science. Friday must not become 'fade away day' and so the meeting will finish at around 15.00 hours giving everyone time to get back home for the weekend.

All work and no play makes Jack the Surgeon a dull boy, and so your committee has woven fun material into the programme throughout – from the humanities, cracking social events through to wine tasting and some of the other finer things in life. This, plus a wonderful opportunity for touring and socialising, participating in the annual golf match, and some fine wining and dining will ensure that your time is well spent.

All in all, I can hardly wait to see the outcome of what we have arranged, so mark the dates in your diary now!

ELECTRONIC SUBMISSION OF FREE PAPERS

The meeting will, once again, feature a paperless electronic abstract submission system. This system enables the surgical community to “copy & paste” abstracts (including tables and special scientific characters, but **not** figures or diagrams) directly from word processing software, facilitating quick and painless abstract submission.

As well as being available via the ASGBI website www.asgbi.org.uk the system is available at www.iformix.com and www.electronicabstract.com.

Submission opens on **Monday 1st August 2005**, and will close at midnight on **Friday 11th November 2005**.

GUIDELINES FOR THE SUBMISSION OF ABSTRACTS

- Abstracts must consist of four paragraphs, entitled: Objective, Methods, Results, Conclusions.
- Abstracts are to be submitted as text and tables only (**ie. no figures, or diagrams**).
- The text should be no longer than 250 words and fit comfortably on a single page of A4 using 12-point font.
- An author must be a Fellow of the Association (unless the abstract has been submitted from overseas).
- As the abstract will be judged anonymously, the text must not reveal the institutional affiliation.
- The category which best describes the subject of your work should be indicated.
- If the abstract is to be considered for the Moynihan Prize, the relevant box should be marked (see “**Prizes and Awards**” overleaf).
- The material must not have been previously published or presented at any major meeting.

ASGBI takes a serious view of Research Governance. Please ensure that the abstract has been seen and agreed by all of the named authors before submission. All authors have a responsibility to ensure that the data submitted is accurate, is not extrapolated and fairly represents the presentation to be given at the Association’s Annual Scientific Meeting.

PRIZES AND AWARDS

Moynihan Prize

This is the Association's most prestigious scientific award. The award consists of £1,000 together with a medal and is presented to the author of the best research work delivered at the Annual Scientific Meeting. The person reading the paper must be the principal research worker and have been qualified for less than fifteen years. In the case of multiple-author papers, the Medal will be presented to the person reading the paper and the award may be divided between the authors.

The paper should have a scientific basis and clinical application; case reports and audit reports should not be submitted. The paper must not have been submitted previously to any other national or international association nor published in any Journal at the time of submission. Shortlisted papers which are found to have been presented elsewhere, or have been accepted for presentation elsewhere, will be disqualified.

If selected, competitors will be required to submit a manuscript suitable for publication. The Moynihan Prize paper shall become the property of the Association and will normally be published in the Association of Surgeons' issue of the *British Journal of Surgery*.

Papers submitted for the Moynihan Prize and not shortlisted will be considered for the Short Paper sections of the meeting.

SHORT PAPERS

There will be several sessions for short papers, and any Fellow or Affiliate Fellow wishing to submit or sponsor a paper for this part of the programme is asked to access the websites listed above by Midnight on **Friday 11th November 2005**. Abstracts should not have been presented elsewhere at the time of submission. Please note that all accepted abstracts, whether for oral presentation or a poster, will be published in the *British Journal of Surgery* supplement.

Failure to present such an abstract, unless it is formally withdrawn at the time that acceptance is notified, will be taken seriously. The names of the authors will be published in the next edition of the Association's *Newsletter*.

There will be six Short Paper Prizes, and the winner in each category will receive a cheque for £150. Adjudication will take place in each of the specialty "Six of the Best" short paper sessions. Judging will be undertaken by the joint Chairmen of the Six of the Best sessions, and the winners will be announced, by the Chairmen, at the end of each session.

John Farndon Prize

The *British Journal of Surgery* has endowed a prize of £500 for the best manuscript to be published in the Journal after the work has been accepted in abstract form for the meeting. Other papers may be published but their inclusion in the Journal is subject to the usual system of editorial review.

VIDEOS/DVDs

John Wiley & Sons, Ltd. Audio Visual Prize

The annual competition for the best video or DVD has been generously sponsored by John Wiley & Sons, Ltd. There will be two categories of award:

- Entries produced "in-house" by a consultant surgeon in association with his/her department of medical illustration.
- Entries produced more "commercially" by a consultant surgeon with external technical or financial assistance.

The winner in each category will receive a plaque and a cash prize of £300.

Presenters are asked to note that the Association may reserve the right to allow the Surgical Royal Colleges to catalogue and manage the selection in their libraries.

Entries must be of general surgical interest, suitable for an audience of consultants and higher surgical trainees and may include topic presentations as well as operative surgery. Commentaries must be in English, and entries must be on SVHS format videotape or DVD and be no longer than 10 minutes duration. Any film that lasts longer than 10 minutes will not be accepted. A two minute discussion will follow each presentation.

Entries will be judged according to surgical interest, teaching value and technical merit. Those accepted will be shown at the Annual Meeting where a presenter should be available for questions. A list of equipment used for the production must accompany each entry, together with full names and qualifications of those most involved in the making of the videotape (maximum 4 names). The Association reserves the right to show or not to show any entry.

Videos or DVDs, accompanied by a completed Entry Form (given on page 11 of this booklet) must be sent to the Director of the Scientific Programme, Association of Surgeons, at the Royal College of Surgeons, 35/43 Lincoln's Inn Fields, London, WC2A 3PE and be received by the closing date of **Friday 11th November 2005**.

FELLOWSHIP OF THE ASSOCIATION

The Association of Surgeons of Great Britain and Ireland was founded in 1920 by a group of leading surgeons of the day. The guiding spirit and inspiration behind the concept was Berkeley Moynihan, later Lord Moynihan of Leeds, who had been struck by the lack of cohesion among surgeons as early as 1909. He wrote that *"surgeons in one town knew little or nothing of surgeons elsewhere. A surgeon from Manchester had never visited an operating theatre in Leeds, nor had ever been asked in consultation. As a consequence it was not infrequent to have to listen to disparagement of one surgeon by another; and jealousies, openly expressed, were too often heard."* The founding objectives of the Association, therefore, were twofold - the advancement of the science and art of surgery and the promotion of friendship amongst surgeons.

The first meeting was held in London under the presidency of Sir John Bland-Sutton, the second in Edinburgh, and the third in Leeds under the Presidency of Moynihan himself. Since then meetings have been held in many other centres in England, Scotland, Wales and Ireland. In recent years there have been additional autumn meetings, often held overseas, and successful visits have been made to many countries around the world.

Initially, the Fellowship was limited to two hundred and fifty consultants. Women were first admitted in 1936 and, in 1953, an Associate Fellowship was introduced for a limited number of trainee surgeons. In 1970, fifty years after its foundation, the Fellowship was opened to all Consultant General Surgeons and more recently, through links with the Association of Surgeons in Training, all Specialist Registrars in general surgery have been eligible for Affiliate Fellowship. In 1992 the title of Associate Fellowship was introduced for Non-Consultant Career Grade Surgeons and this membership is now expanding. The Association aims to achieve close to one hundred per cent membership, to represent General Surgery convincingly within the Colleges and to Government.

The Association is the specialty association for General Surgery and its umbrella status is reflected in the structure of Council and its Committees. There is representation from The Association of Breast Surgery at BASO, The Association of Coloproctology of Great Britain and Ireland, The Association of Laparoscopic Surgeons of Great Britain and Ireland, The Association of Upper Gastrointestinal Surgeons of Great Britain and Ireland, The British Association of Endocrine Surgeons, The British Transplantation Society, The Vascular Society and the Society of Academic and Research Surgery. Additionally, Council includes representation of the Association of Surgeons in Training, the Armed Forces and the UEMS Monospecialist Committee in General Surgery.

New Fellows are always welcome, and we would be pleased if you would discuss Fellowship with any colleagues who are not at present Fellows of the Association. Candidates for Full Fellowship must be Consultants or associate specialists of good standing. Sponsorship by two existing Full Fellows is

required. Staff grade equivalent surgeons are eligible for election as Associate Fellows. Trainees who hold Specialist Registrar status shall, upon election, be appointed as Affiliate Fellows. Affiliate Fellows attaining Consultant status are encouraged to apply for Full Fellowship. Application Forms are available from the Association's offices or website: www.asgbi.org.uk
